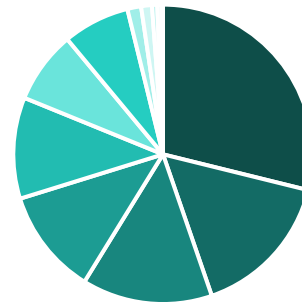
Risk profile
